7. If the photograph contains any material or elements that are not owned by the entrant or which subject to the rights of third parties, or if **any persons appear** in the photograph, the entrant is responsible for obtaining, prior to submission, any releases and consents necessary to permit the exhibition and use of the photograph
8. Parents or guardians submitting photos under the age of 18 are giving full permission for Paintearth Economic Partnership Society to use the entries for promotional and informational print and electronic publications
9. All entrants are required to sign a release for each photo submitted, which can be downloaded from the Paintearth Economic Partnership Society's website at www.paintearth.ab.ca Photos which are not accompanied by a signed release will not be considered eligible for entry into the contest
10. Personal images and information will be used in accordance with the Freedom of Information and Protection of Privacy Act/Personal Information Protection Act.
